I AGREE:

- The Texas A&M Transportation Institute ("TTI"), The Texas A&M University System and its Board of Regents, and their members, officers, agents, volunteers, and employees ("Releasees" or "Indemnitees") are not responsible for any claims, demands, injuries (including death), property damage to vehicles or buildings, or damages, including court costs and attorneys' fees and expenses that may occur due to the use or improper use of the resource(s) selected from the list above ("Resource(s)"), injuries that may occur while transporting the Resource(s), and including injuries resulting from the sole, joint, or concurrent negligence, negligence per se, statutory fault, or strict liability of Releasees.
- That I am aware that there are inherent risks to me and others involved with the use of the Resource(s) and that the virtual reality experience equipment (VR) and other similar equipment may have certain risks, including but not limited to the risk of injury resulting from possible malfunction of the equipment, and possible nausea, dizziness, seizures, disorientation, and other negative reactions to VR or the equipment. I acknowledge that since VR is a new technology, there may also be unknown and nonobvious risks. I choose to voluntarily utilize and allow users to participate in the use of the Resource(s) with full knowledge that the Resource(s) may be hazardous to me and my property, users, and to the person and property of others. I acknowledge there may be physically strenuous activities.
